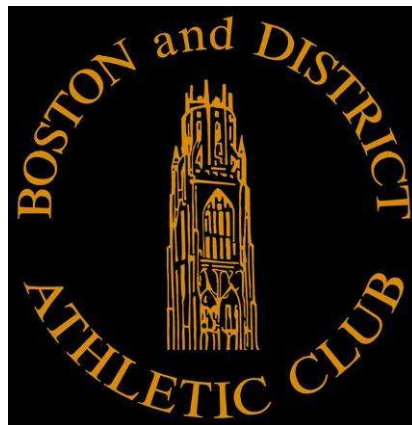

## What is The 200 Club and who are Boston & District AC?

The 200 Club is being introduced to assist in raising funds for Boston & District Athletic Club (BDAC). Our club is based in Boston, Lincolnshire and was formed on the 31st March 2000. This new club arose from the need to serve the athletes in the area. We offer total access and participation from recreational to international athletics, from infant through to senior citizen as well as catering for all disabilities.

### *Our Philosophy – Access for All – No Barriers*

The 200 Club is simplicity in itself to join and every participant gets the chance to win in the monthly draw. Members must be over 16 years old to join and pay by standing order (cheques are accepted for annual payment – no cash will be collected).

All you need to do is complete your details on the combined application form/standing order mandate (enclosed) and hand it back.

You will receive a card (or e-card if you provide email details) confirming your monthly numbers, and the winning numbers will be displayed on the B-Hive notice board and club website after each draw takes place.

Although we are calling it The BDAC 200 Club, we will run with however many subscribers we can get – the more the merrier and the more you can win!

The rules are simple: The tickets are £3 per month if paying by standing order (£36 per year by cheque/cash). BDAC will pay out as follows on a monthly basis:

1st Prize	£100 drawn monthly *
2nd Prize	£50 drawn monthly *
3rd Prize	£25 drawn monthly *

In December of each year, in lieu of the normal prizes, BDAC will pay out as follows:

1st Prize	£500 drawn *
2nd Prize	£250 drawn *
3rd Prize	£150 drawn *
4th Prize	£100 drawn *
5th Prize	£50 drawn *

Anyone can join – athletes, coaches, friends, family and work colleagues.

Please note that monthly subscriptions must be received before the draw otherwise your numbers won't be included – so we have made the date of the standing order payments as the 1st of each month.

## BDAC 200 CLUB RULES

- 1** The name of the draw is the BDAC 200 Club ("the Lottery") regardless of the number of shares that are in existence at any time.
- 2** The purpose of the Lottery is to raise funds for the sole benefit of Boston & District Athletic Club ("the Club"). The BDAC Committee will determine the specific projects to which funds will be allocated. All of these will reflect the aims and objectives of BDAC. BDAC is a registered charity 1133406.
- 3** The Lottery will be administered by a Promoter, appointed by the Committee of BDAC.
- 4** The Prizes will be monthly prizes of £100, £50 and £25 per 200 shares subject to the rules of adjustment as stated at (5). There will be exceptional December prizes £500, £250, £150, £100 and £50 which will not exceed stated values but will be adjusted down under the rules of adjustment as stated at (5). The Lottery will begin and will run continuously from 1st May 2011 and the first draw shall be in May 2011
- 5** Rules of Adjustment: Prizes will be offered on a pro-rata basis until 200 shares in the Lottery have been taken up. For example, if only 50 shares (or tickets) have been sold at the date of the first monthly draw then only 50/200ths (or ¼ in this example) of the prize money will be paid.
- 6** The Lottery will be open to anybody aged 16 or over. A purchaser of a share becomes a participant in the Lottery for a minimum of 1 Year, after this it will become a rolling yearly contract.
- 7** The number of shares in the Lottery shall not be limited to a maximum of 200. Each share shall be allocated a unique number. Membership tickets will be issued. Participants may confirm the number of their allocated share(s) by contacting the Promoter. When 200 shares are exceeded a further draw will take place using the rules of prize adjustment as stated at (5).
- 8** The subscription for each share is £3 per calendar month payable monthly in advance by standing order. Participants may also pay annually in advance by Standing Order or cheque (made payable to Boston & District AC).
- 9** There shall be a draw made on the second Tuesday of each month at a club training session using an automatic random generator or other such means as the Promoter deems appropriate. The draw must be held in the presence of at least 2 members of the BDAC Committee. One of the present Committee members may be the Promoter if that person also happens to be on the Committee.
- 10** Winners will be paid by cheque, which will be sent to the last known address held by the Promoter. It is the responsibility of the participant to advise the Promoter of any change of address. Any prize cheque not cashed within 45 days will be deemed a donation to BDAC. A list of prize winning numbers will be published on the B-Hive notice board on a monthly basis and within 7 days of any draw taking place.
- 11** The Promoter will not pay a prize to any Participant other than the purchaser of a winning share.
- 12** No Lottery participant will be included in the draw if their subscription has not been received but will remain liable for the remaining year balance. It is the responsibility of each Participant to make sure they have paid their subscription. The Promoter reserves the right to reallocate any number where payment has not been received.
- 13** Participants can cancel their yearly entry in the Lottery at any time by giving one month's minimum written notice to the Promoter before their final month is due. Any decision by the BDAC Committee to end the Lottery can be by one month's notice to all Participants.
- 14** Under no circumstances can subscriptions be refunded.
- 15** The Promoter will determine any dispute. An appeal may be made to the BDAC Committee whose decision shall be final.
- 16** The Lottery is intended to be a Small Society Lottery under the provisions of the Gambling Act 2005 Section 19.
- 17** The BDAC Committee may amend or vary the rules of the Lottery at any time. The rules of the Lottery will be available via the B-Hive notice board and club website. Changes will be notified to Participants via these means.
- 18** The Original Rules were adopted at a meeting of Boston & District AC Committee on Monday 14<sup>th</sup> March 2011. The Promoter of the Lottery with effect from this date is to be Selwyn Auty of 3 Rochford Crescent, Boston, Lincs., PE21 9AE.
